Accordingly, when students enrol at your School they will receive the official PEN number from the B.C. Ministry of Education, Canada.

- ✚ Candidate Status (informal on-site visit/review);
- ✚ Certification Status (formal on-site inspection team);
- ✚ Maintaining certification status (annual on-site inspection);
- ✚ All BC program and inspection fees covered by host school.

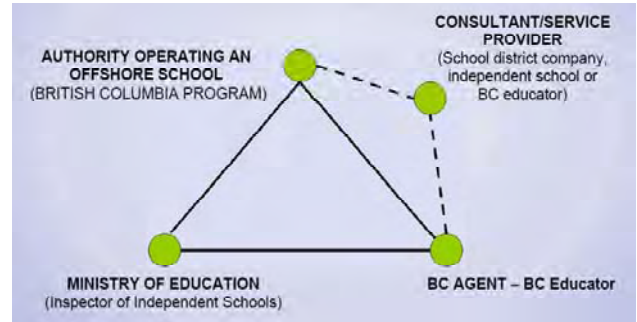

OUR BC AGENT/CONSULTANT ROLE

The following list has been outlined by the British Columbia Ministry of Education requirements in reference to the required usage of Halladay Education Group as your Agent and Consulting Firm:

- ✚ Complete oversight in the formation process of your school;
- ✚ Administrative consultation/guidance for the successful start-up and operation of your school;
- ✚ Policy and infrastructure development;
- ✚ Curriculum and resources development;
- ✚ Recommendations for purchases of educational resources;
- ✚ Recruitment of British Columbia-certified Principal and teachers;
- ✚ Completion of Ministry of Education documents necessary for certification and annual accreditation;
- ✚ Professional development;
- ✚ Ongoing support for the operation of the school and much more.



ACCREDITATION

The Ministry of Education has developed a stringent multi-step process to establish and operate BC-certified Offshore Schools. You will need to apply for "Candidate" and then "Certification" Status working with your designated Agent, leading you through the rigorous accreditation and school formation process. Your school will have onsite inspections by the BC Ministry of Education, as well as an accreditation inspection once the school is operating. Furthermore, your students will need to be taught the K-12 learning outcomes of BC's Integrated Learning Resources (IRP), and government exams in Grades 10, 11, and 12 to graduate with an authorised BC Certificate of Graduation (Dogwood). However, the efforts will be worth it – you have a guarantee of quality, and a universally accepted educational model that prepares children for success, and status as one of the most esteemed and rigorous education programs in the world.

MINISTRY OF EDUCATION PROGRAMMING FEES

- ✚ \$200 one time per student fee on entering the BC Certified Program at Kindergarten to Grade 9;
- ✚ \$350 one time per student fee on entering the BC Certified Program at Grade 10, 11 or 12;
- ✚ \$50 fee for each additional Grade 12 examination written in addition to English 12;
- ✚ \$2,500 Candidate Status application fee;
- ✚ \$3,500 Certification Status application fee;
- ✚ Pre-payment of all on-site inspection team costs (professional fees, air, food, lodging, transportation, etc.);
- ✚ Contract between offshore school and BC Agent (the consultant/service provider) for start-up and operation.
